**Pogoji za vključitev v delo oz. za
opravljanje študijskih obveznosti:**

Opravljenе vse obveznosti prvega in drugega letnika, pripravljen (vsaj) osnutek doktorske disertacije in solidno pripravljen zagovor disertacije.

Prerequisites:

All obligations from the first and the second year, (at least) a draft of the doctoral dissertation, and a well prepared defense presentation.

Vsebina:

Cilj predmeta je finalizacija doktorske disertacije v sodelovanju s mentorjem in s člani komisije za zagovor. Predmet temelji na predstavljanju, zagovarjanju in izboljševanju osnutkov doktorske disertacije. Študent predmetu pristopi s dokončano (ali skoraj dokončano) disertacijo in s že razdelanim planom zagovora.

Študent k seminarju pristopi s prvim osnutkom doktorske disertacije, ki mora vključevati najmanj:

Content (Syllabus outline):

The aim of the course is finalized doctoral dissertation in collaboration with mentor and members of the defense committee. The course is based on presenting and improving the draft of the doctoral dissertation. The student approaches the course with a complete (or nearly complete) dissertation and an elaborate plan for the defense.

Student's first dissertation draft must include at least the following:

- clearly formulated research question and/or hypothesis,

- jasno formulirano raziskovalno vprašanje in/ali hipoteze,
- predstavitev uporabljenih raziskovalnih metod,
- vsaj preliminarne raziskovalne rezultate,
- vsaj preliminarno interpretacijo raziskovalnih rezultatov v luči vprašanj/hipotez,
- utemeljitev inovativnosti doktorske disertacije kot relevantnega prispevka k znanosti.

Študent dobi možnost "generalnega poskusa" zagovora, ki je izveden v obliki seminarja (predavanja) pred člani komisije za zagovor in pred ostali študenti. Kandidat tako dobi nasvete za izboljšavo ne samo disertacije, ampak tudi samega zagovora. Hkrati, komisija za zagovor odpravi ali razjasni morebitne pripombe na kandidatovo raziskovalno delo, disertacijo in zagovor. Sodelujoči študenti predstavijo in zagovarjajo svoje osnutke in hkrati kritično presojujejo osnutke drugih študentov.

Predmet se lahko izvaja individualno za posameznega študenta, odvisno od časovnega poteka pisanja doktorske disertacije (prisotnost ostalih študentov je zaželjena, ne pa nujna).

Predmet konča z pozitivno ocenjenim preizkusnim predavanjem. Predmet lahko šteje kot opravljen, če je kandidat že objavil (kot avtor ali kot so-avtor) vsaj en izvorni znanstveni članek v s faktorjem vpliva (SSCI, SCIE ali Scopus).

To je tudi priložnost, da študent razreši morebitna nesoglasja s komisijo za zagovor disertacije in uskali, kateri popravki bodo izvedeni (in kateri ne).

- presentation of the research methods used,
- at least preliminary research results,
- at least a preliminary interpretation of the research results in the light of the questions/hypotheses,
- grounds and arguments for innovativ character of the doctoral dissertation as a novel and relevant contribution to science.

The student is given the opportunity of a rehearsal of his/her defense, which is implemented in the form of a seminar (lecture) in front of the members of the defense committee and peer students. The candidate thus gets comments and feedback towards improving not only the dissertation itself, but also the defence. At the same time, the defense committee can eliminate or clarify possible critiques on the candidate's research work, dissertation and defense. All participating students present their defense drafts while critically evaluating the others' drafts.

The course can be carried out individually for each student, depending on the timing of the writing of the doctoral dissertation (the presence of other students is desirable, but not essential).

The course ends with positively evaluated defense rehearsal. The course can be considered as completed if the candidate has already published (as author or co-author) at least one original scientific paper in the journal with an impact factor (SSCI, SCIE or Scopus).

This is also an opportunity for the student to resolve any disagreements with the defense committee and agree with them which corrections to the dissertation will be implemented (and which will not).

Objectives and competences:

Learning unit contributes to the development of the following general and subject-specific competences:

- respect for scientific ethics
- development of skills and abilities in usage of knowledge in doctoral research
- ability of designing and implementing novel scientific solutions for given social problems
- ability of complex systemic perspective on the society and interdisciplinary approach, which demonstrates the understanding of general structure of social sciences and links among their disciplines and sub-disciplines
- ability to present the obtained scientific findings in form of publications in international scientific journals

Študent/študentka:

- zagovarja svoj osnutek doktorske disertacije vsaj enkrat, ter pridobi komentarje pristonih,
- kritično presoja osnutke doktorskih disertacij svojih študentskih kolegic in kolegov,
- upošteva relevantne pripombe in sugestije s seminarja pri izdelavi končnega besedila doktorske disertacije,
- upošteva nasvete in pripombe za izboljšavo samega zagovora.

Intended learning outcomes:

Knowledge and understanding:

The student:

- defends at least once his/her dissertation draft, and obtains the comments/feedback from the audience,
- critically examines the dissertation drafts from his/her student colleagues (peers),
- Takes into account relevant comments and suggestions in finalizing the doctoral dissertation,
- takes into account the advices and comments towards improving the defense talk itself.
