Objectives:

Offer the students a course on (global) security and introduce them with the key theoretical and practical aspects of the security in the international relations. The course will attempt to develop a critical awareness of current conflicts and other dimensions of contemporary security, which are strongly influenced by transnational

Knowledge and understanding:

- Students are familiar with the fundamental approaches of security studies and knows how to apply them on concrete examples.

- Students know and understand the concept of human security.
- Students critically analyse and reflect on security dynamics and know how to avoid simplifications.
