CRITERIA FOR TRANSFERRING BETWEEN STUDY PROGRAMMES

Article 1

- (1) A transfer between study programmes is the following:
 - an enrolment in the second or higher year of a higher education study programme in the event of termination of education under the first study programme and continuation of study under the second study programme of the same level, or an enrolment of a higher education graduate in a new study programme of the same level:
 - 2. an enrollment of a higher education graduate in the second year of a first level higher education study programme.

Article 2

Article 3

- (1) Depending on the scope of recognized obligations from the first study programme in the Republic of Slovenia or abroad, the student may enroll in the same year or a higher year in a study programme at FIŠ.
